

- 1. Item Code = the 10 digits given under the heading ORDER ID (i.e.: 101.179359)
- 2. Item Description = the name of the item (i.e.: FINALE AG)
- 3. Made in = i.e.: ITALY, PORTUGAL, CHINA...
- **4. Qty =** quantity of items you would like to return
- 5. Unit Price = the unit price of the article without VAT (i.e.: 104,00€)
- 6. Total = Multiply Qty * Unit Price
- 7. Freight Charges = the amount available on the last page on the invoice (i.e.: 20,00)
- 8. Total value for customs purpose only = the sum up of all amounts listed on the column 'Total' (i.e. 124,00)
